Lendreams (COFECC)

Corporación para el Financiamiento Empresarial del Comercio y de las Comunidades (COFECC), now with a new brand name, Lendreams, is a private nonprofit institution and a 501(c)3 established in 1982. The organization is certified as a Community Development Financial Institution (CDFI) as authorized by the US Department of the Treasury. Headquartered in San Juan, Puerto Rico, the organization also covers in addition to Puerto Rico, the US Virgin Islands and was also authorized by the SBA to expand as a microlender to Central Florida (counties of Orange, Lake, Seminole and Osceola). The organization is a nonprofit lender under the SBA Microloan, SBA Community Advantage and SBA 504 Loan Program, as well as a Rural Development Intermediary Lender. The organization also offers two educational initiatives directed to low-income communities which are designated as the Practical Entrepreneurship Academy and Practical Kitchen Academy (which is a workforce development training project has been supported by the Housing and Urban Development Agency under the CDBG-DR Program). These educational initiatives and loan programs have furthered the organization's mission which is to promote, facilitate and execute economic development, community revitalization, long-term job creation and retention, self-employment, business and credit education, and entrepreneurship through the establishment or expansion of micro-, small-, and medium-sized enterprises.
